




















## **Main Research Directions in Human Geography**

21.05.2012 established a working group in the State Migration Service on the formation of statistical information, preparation of sample statistical forms, organization of the procedures for its collection and use.

#### Statistics:

- number of citizens that leaving Ukraine for permanent residence (by countries)
- number of foreigners who acquire citizenship of Ukraine (by countries)
- number of refugees in Ukraine (by countries of origin)
- age structure of refugees in Ukraine

#### SMS includes:

- temporary centers for foreigners and stateless persons who are illegally residing in Ukraine
- ☐ temporary accommodation centers for refugees

12.2011 the Söderköping Process was integrated into the Eastern Partnership, which is EU's policy with its Eastern neighbors. New Panel on Migration and Asylum was established under the Eastern Partnership's Platform 1`Democracy, Good Governance and Stability'

#### Statistics:

- asylums seekers and refugees: number of asylum applications filed, number of recognitions of refugee status (by counties of origin and destination)
- irregular migration: number of irregular migrants identified in the country (by counties of origin and destination)
- illegal border crossing: number of persons apprehended at the border, number of entries denied (by counties of origin and destination)
- immigration: number of residence permits issued (first permit issuance and renewals)
- emigration: total number of own nationals emigrated

### **On Labor Migration:**

#### √ Foreign Labor Migration of Ukraine's Population

The first national population sample survey on labor migration. <u>Polled more than 48 thousands people</u> of working age (women aged 15-54, men 15-59 years old) - from 22 thousand households all <u>over the country</u>.

## ✓ The Study of Labor Migration and Trafficking in Belarus, Bulgaria, Moldova, Romania and Ukraine

Personal interviews in respondents' homes. <u>1313 interview</u> in Ukraine with respondents aged 15-59. <u>Random route</u> sampling of respondents

### √ The Study of Ukrainian Labor Migrants' Needs

<u>Focused group discussions</u> (FGD) in three regional administrative centers: <u>Kharkiv, Uzhgorod and Ternopil'</u>. Altogether 6 FGD were carried out with <u>50 respondents</u> aged 18 to 63.

Analysis revealed that there are two types of territories in Ukraine, with high and low pressure on the labour market.

Participatory Assessment <u>consultations with refugees, asylum seekers and stateless persons in</u> <u>the Autonomous Republic of Crimea, in Kharkiv and in Kyiv</u>

## ✓ Increasing the Ability to Protect and Support Refugees and Asylum Seekers in Transcarpathia/Ukraine

The target group includes <u>individuals</u> detained at <u>Transcarpathian border crossings (Chop, Pavshyno, and Mukachevo</u>), and <u>staff members from the refugee centre in Mukachevo</u>.

### ✓ Refoulement of Refugees and Minors on the Eastern Borders of the EU – the case of Hungary, Slovakia and Ukraine: Border Monitoring Project Ukraine (BMPU)

Situation of refouled <u>refugees and other vulnerable migrants in Transcarpathia</u> (Ukraine). <u>15 refugees</u> complain about the violation of their rights (in particular Case of an Afghan minor crossing the Hungarian-Ukrainian border)






## Focus on District (Rajon) Level: Migration Patterns in Urban Regions




















## Focus on District (Rajon) Level:

## Migration Pattern in Metropolitan Agglomeration




Average Annual Net Migration in Kyiv's Hinterland in 2005-2009


## Migration Pattern in Metropolitan Agglomeration




### Net migration, 2010

Inflow net migration increase is typical only for interregional centers Kyiv and Odessa that primarily concerned with their status and geographical situation. Maximum migration growth is in suburban areas around Kyiv, Dnipropetrovs'k, Kharkiv, L'viv, Odessa



## **Focus on Neighbor countries**

- Reasons of Ukrainian labor migration to the Visegrad countries: Push-Pull factors (economic, socio-psychological, administrative, geographical)
- Evolution of Ukrainian labor migration to the Visegrad countries
- Ways of Ukrainian labor migration to the Visegrad countries (chain migration, recruitment agencies, direct contacts with employers)
- Problems of Ukrainian labor migration to the Visegrad countries (for Ukraine, and for V4)
- Barriers for Ukrainian labor migration to the Visegrad countries (administrative, informative, socio-psychological)
